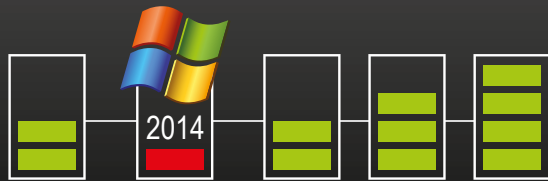

Business Problems

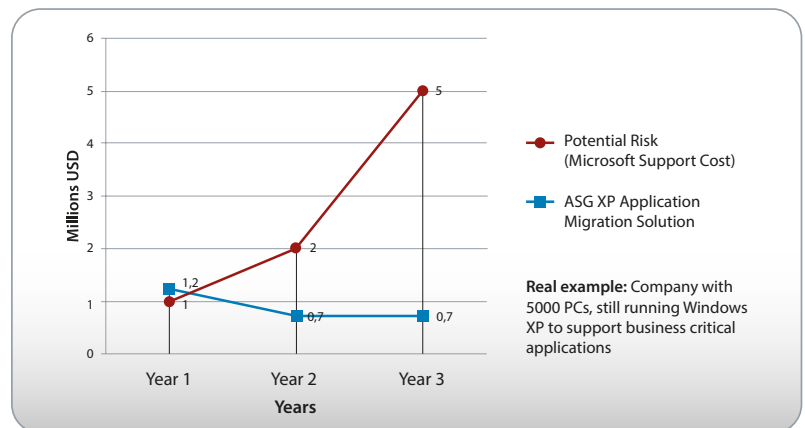
- Businesses are dependent upon specific business-critical applications
- Many of these critical applications are still based on Windows XP
- Businesses would like to migrate their PCs and laptops to more modern operating systems (OS) like Windows 7 or 8 but are stuck with XP

Technical Problems

- Redevelopment of the XP-based application(s) to work with newer OS can take up to three years and cost a lot of money (one of our customers said he would have to spend more than \$100 million over five years)
- Some of our customers have tried other virtualization solutions from well-known vendors that have failed

Financial and Licensing Issues

- Microsoft XP is not a perpetual license. The End of Life and Support is in April 2014
- A company with 5000 Windows XP users will be facing the following Microsoft support costs in the coming years:
- 2014: \$1 million (5000 PCs at \$200 each)
- 2015: \$2 million (\$400 per PC)
- 2016: \$5 million (\$1000 per PC)
- Total: \$8 million
